**Notice of Nominations for Office**

Notice is hereby given to the Municipal Electors of the Township of Hamilton that nomination papers for the 2018 Municipal Election may be filed in person or by an agent with the Municipal Clerk/Returning Officer as of Tuesday May 1<sup>st</sup>, 2018 up to Thursday, July 26<sup>th</sup>, 2018 at the Municipal Clerk's Office, 8285 Majestic Hills Dr. Camborne, ON. between the hours of 8:30 am and 4:30 pm and on Nomination Day, Friday, July 27<sup>th</sup>, 2018 between the hours of 9:00 am and 2:00 pm.

The required nomination fee for a Member of Council/School Board Trustee is \$100.00 and the required fee for the head of Council is \$200.00/ The required fee shall be in the form of cash, debit, a certified cheque or money order made payable to the Township of Hamilton and must accompany the signed Nomination form.

**New Requirement this year: For each Nomination paper, a Candidate Endorsement form must be included (excluding School Board Trustee Candidates) signed by 25 eligible voters supporting the nomination.**

The individuals providing signatures must sign a declaration stating that they are eligible to vote in the Municipality on the day they sign the endorsement.

You are entitled to be an elector and to run for office if you are not disqualified by any Act or Law and on Voting Day if you are:

1. A resident of the Township of Hamilton;
2. A non-resident, who is an owner or tenant of land in the Township or the spouse of or same sex partner of such owner or tenant;
3. A Canadian Citizen; and
4. Of the full age of 18 years.
